Financial management of non-state pension funds

The essence and features of the financial management of non-state pension funds are given ground in this article. There is also disclosed the mechanism structure for managing non-state pension funds in terms of methods, instruments and tools which structure is decomposed accordingly to the stages of the financial management. The basic stages of the process of attracting pension contributions to private pension funds and the process of investing pension assets are outlined. Recommendations for choosing a fund's investment strategy with regard to the criteria and constraints of the investment portfolio are stated. The practice of involvement, investment and usage of financial resources of private pension funds are analyzed and the main tendencies and problems in their work are found. Some measures to optimize the management of financial resources at various stages of non-state pension funds are offered here.

System of subjects of non-state pension provision sphere as a social and economic cluster

The accumulative pension system, which is organized as non-state pension funds, is considered as a socio-economic cluster for the first time. The group of legal entities as elements of such a cluster is defined as well as their place and role in the area of the non-state pension provision. There have been found indication, which allow examining their aggregate as a system incorporated on a functional basis. Municipal pension funds as regional clusters, which enable complex solution of public welfare for the inhabitants of the region as well as financing local-authorities and local companies, are considered separately. There are suggested ways for increasing the efficiency of functioning of accumulative pension system as sinergetic result of its clusterization.

A comparative analysis of the average population number in the smallest territorial regions in developed foreign countries and in Ukraine has been done. The main stages of the administrative-territorial practice of the XXth — beginning of the XIth century as approved by the European Commission in 1998 at "Nomenclature of territorial units for statistical purposes" (NUTS) has been analyzed. The features of administrative-territorial structure of foreign countries have been investigated and the conclusions regarding the applicability of this experience in domestic practice have been made.
