The State Educational-Scientific Establishment "The Academy of Financial Management," in the framework of the implementation of the tasks assigned by the Cabinet of Ministers of Ukraine "The issues of coordination activity of some scientific institutions" on September 23, 2014 № 473, supported by the Ministry of Finance of Ukraine, the Ministry of Education and Science of Ukraine, the world's recognized international institutions in the field of scientific, organizational and educational support of building a single mental space for reforming financial and economic spheres in countries with a transitive type of economy (e.g. the German International Cooperation (GIZ), the IMF Institute for Capacity Development (ICD), the National Academy for Finance and Economics under the Ministry of Finance of the Netherlands, the UNICEF Representation in Ukraine, etc.), using modern information and communication technologies, findings of national and international finance research, the development of public finance management in terms of European integration processes, provides training for employees in public and corporate finance to assure the effective realization of the reforms initiated by the President and the Government of Ukraine. This webinar enabled world-recognized top-level scholars and lecturers, such as Jim Wright, to communicate knowledge and helped to address pressing issues related to key organizational risks encountered in implementing complex strategic initiatives. Holding webinars on a regular basis may become an important factor in forming the distance education system (upgrading) for a wide variety of top managers responsible for decision-making in Ukraine's public finance sector.
