

REQUIREMENTS FOR PAPERS ARRANGMENT for journal “GEODESY, CARTOGRAPHY AND AERIAL SURVEY”

The Journal submit for publication papers in Ukrainian, Russian or English of problematic, general, methodical character, original scientific and practical researches that has never before been published.

Scientific publication in the professional journal “Geodesy, Cartography and Aerial Photography” should take into account the requirements of international scientometric databases (SciVerse Scopus, Web of Science, etc.) to scientific papers.

The main material of the article should have the following elements:

- Introduction (problem statement, analysis of recent researches ...)
- Aim;
- Method;
- Results;
- Scientific novelty and practical significance;
- Conclusions.

The structure of a paper (pages – not numbered!):

- **UDC index** (upper left corner of the page);
- **a complete list of (co)authors (initials and surnames, order number on the list and in addition to co-author for correspondence – an asterisk (superscript))** – in the second, or following lines;
- **information about (co)authors:** footnote (superscript – Arabic numeral and further asterisk for corresponding author) [if there are two or more authors], the place of work, postal address (building, house, street, town, country) for (co)author for correspondence – additionally telephone numbers, fax, e-mail (obligatory!).
- **title of paper;**
- **abstract** (one paragraph, from 250 words) – should be structured (logically describe the results in the paper) and must contain the following elements of their explicit allocation: **aim, methods, results, scientific novelty, practical significance;**
- **keywords** (5–12 of certain words and / or in multiple combinations, in which can be a comma);
- **the main text** of the paper is placed in two columns of equal width;
- **references (two columns** structure of paper remains) are given in square brackets [author, year] and match to the lists, arranged as follows: first all references in Cyrillic alphabet from А to Я, then all Latin letters (A ... Z), listed in alphabetical order. Bibliographic record of literature should be made out according to the standard “DSTU 7.1:2006. System of standards on information, librarianship and publishing. Bibliographic Records. Bibliographic description. General requirements and rules”, that the incumbent on 01.07.2007. In accordance with requirements of SCOPUS and Web of Science it is necessary to submit a complete list of co-authors for each referrer (as opposed to the specified DSTU). Primary sources are submitted in the original language.

Requirements for a list of references:

- volume – at least 13 sources;
- at least 3 sources in Latin letters on foreign journals with high impact influence, i.e. sources which are in the international scientometric databases;
- most of the references (including the original foreign sources) must be not older than 34 years;
- it is allowed no more than 20 % self-referencing on each of the co-authors.

List of references is placed in alphabetical order and provided with subtitle СПИСОК ВИКОРИСТАНИХ ДЖЕРЕЛ (for Ukrainian papers) СПИСОК ИСПОЛЬЗОВАННЫХ ИСТОЧНИКОВ (for Russian paper) or REFERENCES (if the article is in English).

The presence of references in the paper is mandatory!

- **abstract in form of one column: a complete list of (co) authors (initials and surnames sequence number on the list and in addition for co-author for correspondence – an asterisk (superscript)), information about the (co) authors, paper title, abstract, keywords in Russian (for Ukrainian-language papers) and Ukrainian (for Russian papers);**

- **block in English and Latin – serves as an independent source of information; its format meets the same requirements as to the paper: full list of (co) authors (transliterated initials and surnames on the list and in addition to the co-author (for correspondence) – asterisk (superscript)); information about the (co) authors**

(transliterated names of organizations and streets); title of the article; abstract (one paragraph, with volume from 250 words, no less than 16 lines) should be structured (logically describe the results obtained in the paper) and must contain the following elements with their explicit allocation: the purpose, methods, results, scientific novelty, practical significance; keywords (English translation by an expert); keywords (5–12 individual words and/or combinations, before the list of words it should be printed by Italics the word *Keywords*;

– References (REFERENCES) – Ukrainian and Russian literature transliterated Latin letters according to the rules of transliteration (see. table) and in brackets is added translation of the title and publication in English.

It is recommended to use automatic transliteration systems.

The site <http://www.translit.ru/> is free and can be used for transliteration of Russian text into Latin, using the required system of transliteration.

The site http://shub123.ucoz.ru/Sistema_transliterazii.html is free and can be used for transliteration of Russian text into Latin in terms of the Rules of transliteration of the State Department of USA.

The site <http://translit.kh.ua/#passport> is free and can be used for transliteration of Ukrainian into Latin text in terms of the Resolution of the Cabinet of Ministers of Ukraine dated 27 January 2010. № 55.
