

Journal “Geodesy, Cartography and Aerial Survey” – REQUIREMENTS FOR PAPERS

The Journal accepts for publication papers on problematic, general and methodological issues, original scientific and practical researches in Ukrainian or English that have never been published before.

Scientific publication in the professional journal “Geodesy, Cartography and Aerial Photography” should meet the requirements of international scientometric databases (SciVerse Scopus, Web of Science, etc.) set for scientific papers.

Article should contain the following parts:

- introduction (problem statement, analysis of recent researches ...)
- aim;
- method;
- results;
- scientific novelty and practical significance;
- conclusions.

The structure of a paper (pages should not be numbered!):

- **UDC index** (page upper left corner);
- **complete list of (co)authors (initials and surnames, reference number on the list, a superscript asterisk should be put after the surname of a corresponding (co)author;**
- **information on (co)authors:** footnote (superscript – Arabic numeral and additional asterisk for a corresponding author) [if there are two or more authors], place of work, postal address (block/building, street, city, country), corresponding (co)author should specify his/her telephone numbers, fax, e-mail (obligatory!).
- **title of a paper;**
- **abstract** (one paragraph, not less than 250 words) should be structured (consistent with the description of results in the paper) and should contain the following explicitly allocated elements: **aim, methods, results, scientific novelty, practical significance;**
- **key words** (5–12 words and/or phrases divided by comma);
- **main part** of a paper is arranged in two columns of equal width;
- **references (two-column arrangement should be preserved)** should be in square brackets [author, year]. In accordance with requirements of SCOPUS and Web of Science it is necessary to submit a complete list of co-authors for each source of reference. Primary sources should be given in the original language.

Requirements for the list of references:

- amount – at least 13 sources;
- at least 3 foreign sources published in journals with high impact influence, i.e. sources which are in the international scientometric databases;
- most of the references (including the original foreign sources) should be 2000;
- it is allowed not more than 20 % self-referencing per each of the co-authors.

List of references should be presented in alphabetical order and provided with subtitle **REFERENCES. Each article should mandatory contain list of references!!**

- abstract should be page-wide: a complete list of (co) authors (listed transliterated initials and surnames; corresponding (co)author’s name – asterisk (superscript)), information on (co)authors (transliterated names of organizations and streets), title of an article, abstract (one paragraph, not less than 250 words) should be structured (consistent with the description of results in the paper) and should contain the following explicitly allocated elements: purpose, methods, results, scientific novelty, practical

significance; key words (5–12 individual words and/or phrases, before the list of words it should be printed *Key words* in Italics);

– References (REFERENCES) – Ukrainian sources should be transliterated in Latin letters according to the rules of transliteration and in brackets a translation of the title and publication in English is added.

Papers submitted in the journal “Geodesy, Cartography and Aerial Survey” pass through closed editorial and double blind independent review.

Reviewing is performed per the following criteria:

Does the content of the paper correspond to its title?
Is the author’s study a new contribution to the science?
How do you assess the literary style of an article? (low, proper)?
Is the aim of a paper formulated properly? (in particular, whether it corresponds to the content of the paper)?
Are there keywords present?
Are there methods of research mentioned?
Are there enough literature references processed?
Are the obtained scientific research results substantiated enough?
Is the scientific novelty of work substantiated logically?
Is there practical importance of the research?
Are there conclusions?
Are the prospects for further research indicated?
