# Localization of magnon modes in a curved magnetic nanowire

#### Abstract

Spin waves in magnetic nanowires can be bound by a local bending of the wire. The eigenfrequency of a truly local magnon mode is determined by the curvature: a general analytical expression is established for any infinitesimally weak localized curvature of the wire. The interaction of the local mode with spin waves, propagating through the bend, results in scattering features, which is well confirmed by spin-lattice simulations.

## 1. Introduction

Spin waves as collective excitations of magnetically ordered medium were introduced by Bloch [1] in 1930, where he predicted that spin waves should behave as weakly interacting quasiparticles obeying the Bose-Einstein statistics. These quasiparticles, as quanta of spin waves, are called magnons: the dynamic eigen-excitations of a magnetically ordered body. A wide variety of linear and nonlinear spinwave phenomena boosted the interest into the fundamental properties of the spin waves [2-4], whereas their transport abilities were of great interest for applications in telecommunication systems [5]. Due to the possibility of building
low-power logical devices, spin waves are considered as potential data carriers for computing devices [6-9]. However, in order to exploit spin waves for data processing in real devices, it requires a means to guide spin waves without disturbance in structures with complicated geometry, which in turn requires bent and curvilinear parts to save space on the chips [10-12].

During the past few years, there has been a growing interest in the curvature effects in the physics of nanomagnets. A crucial aspect of the interest is caused by recent achievements in nanotechnologies of flexible [13], stretchable [14], and printable magnetoelectronics [15]. The topic of magnetism in curved geometries brings about a series of fasci-
nating geometry-induced effects in the magnetic properties of materials [16]. A fully three-dimensional (3D) approach was put forth recently to study dynamical and static properties of arbitrary curved magnetic shells and wires [17,18], and also stripes [19]: the geometrically-broken symmetry in curvilinear magnetic systems results in the emergence of a curvature-induced anisotropy and a Dzyaloshinskii-Moriya interaction (DMI) driven by exchange interaction. The latter effect results in possible magnetochiral effects [20], for a review see Ref. 16. It is known that the curvilinear-geometry-induced DMI is a source of pinning of domain walls by a local bending of the wire [21], it causes a coupling of chiralities in spin and physical spaces for the Möbius ribbons [19,22], it results in a number of nonreciprocal effects in helical wires [23-26], it can even stabilize a skyrmion in a curved magnet [27,28].

The purpose of the current study is to derive conditions when the bending of the wire results in localization of magnon states. Using a recently developed approach for the description of arbitrary curved wires [18] we study the equilibrium magnetization state and spin waves on its background for flat curved nanowires. It is shown that for a smoothly curved flat nanowire the equilibrium state has an almost tangential magnetization distribution with small deviations which are proportional to the first derivative of curvature over the arc length. A truly local mode is shown to be always present for any infinitesimally weak localized curvature of the wire. This internal mode results in certain scattering features of the spin waves.


The paper is organized as follows. In Sec. 2 the relevant model is formulated. We present a general description of the ground state and linear excitations in flat, curved ferromagnetic wires in Sec. 3. We illustrate the proposed approach using a wire with a box-car curvature, i.e., two straight segments connected by a circular arc in Sec. 4. The bound states in the limiting case $\xi_{0} \rightarrow 0$ of a sharp bend are considered in Sec. 5. Numerical simulations are described in Sec. 6 and concluding remarks are contained in Sec. 7. Appendices contain the mathematical details of calculations, described in the main text.

## 2. Model description

We base our study on the phenomenological LandauLifshitz equation

$$

\partial_{t} \mathbf{m}=\frac{\gamma_{0}}{M_{s}} \mathbf{m} \times \frac{\delta E}{\delta \mathbf{m}} \tag{1}
\end{equation*}

which describes the precession dynamics of the classical magnetization unit vector $\mathbf{m}$. Here $E$ is the total energy, $M_{S}$ is the saturation magnetization, and $\gamma_{0}=g \mu_{B} / \hbar$ is the gyromagnetic ratio with $g$ being Landé $g$-factor, $\mu_{B}$ being Bohr magneton and $\hbar$ being Planck constant. The damping is neglected.

Let us consider a curved ferromagnetic wire of a shape given by an oriented plane curve $\gamma(s)$ with a fixed crosssection of area $S$, parameterized by arc length $s$, see Fig. 1(a). It defines a basis in terms of tangential, normal and binormal directions $\mathbf{e}_{T}=\partial_{S} \gamma, \mathbf{e}_{N}=\hat{\mathbf{z}} \times \mathbf{e}_{T}$, and $\mathbf{e}_{B}=\hat{\mathbf{z}}$, respectively. Here $\hat{\mathbf{z}}$ is a unit vector perpendicular to the plane contain-

ing the wire. In accordance with the Frenet-Serret formulae, the curvature $\kappa(s)$ of a planar wire is determined by the relation $\partial_{s} \mathbf{e}_{T}=\kappa \mathbf{e}_{N}$. Introducing the parameterization $\mathbf{e}_{T}=\cos \eta(s) \hat{\mathbf{x}}+\sin \eta(s) \hat{\mathbf{y}}$ one obtains $\kappa=\partial_{s} \eta$. Note that the curvature is positive (negative) for concave (convex) shapes, determined with respect to the $\hat{\mathbf{y}}$-axis.

The total magnetic energy of a sufficiently thin ferromagnetic wire of circular (or square) cross section is wellknown [29], and can be described by reduced onedimensional (1D) energy given by a sum of exchange and local anisotropy terms,

$$
\begin{equation*}
E=S \int d s\left[\mathcal{A}\left|\partial_{S} \mathbf{m}\right|^{2}-K_{\mathrm{eff}}\left(\mathbf{m} \cdot \mathbf{e}_{T}\right)^{2}\right] \tag{2}
\end{equation*}
$$

where $\mathcal{A}$ is the exchange constant and $K_{\text {eff }}=K+\pi M_{s}^{2}$ is the constant of the effective easy-tangential anisotropy, which incorporates the intrinsic crystalline anisotropy $K$ and the shape-induced magnetostatic contribution [29], see also [19]. The orientation of the easy-axis is determined by the coordinate-dependent tangential direction $\mathbf{e}_{T}=\mathbf{e}_{T}(s)$. This is a juncture where a sample geometry appears in the system: we assume that the anisotropy is strong enough to dictate the geometry-dependent magnetization configuration. By choosing the curvilinear reference frame adapted to the geometry we get rid of the coordinate dependence of the magnetic anisotropy term, hence it assumes its usual transla-tion-invariant form. In the following we consider a magnet where such an easy-tangential anisotropy significantly exceeds all other interactions. It is convenient to express the magnetization in terms of the Frenet-Serret local reference frame, $\mathbf{m}=\sin \theta \cos \phi \mathbf{e}_{T}+\sin \theta \sin \phi \mathbf{e}_{N}+\cos \theta \mathbf{e}_{B}$, where the angular variables $\theta$ and $\phi$ depend on spatial and temporal coordinates. In the curvilinear reference frame the total energy (2) reads $E=E_{0} \int \mathcal{E} d \xi$ with the energy density [18]

$$
\begin{equation*}
\mathcal{E}=\theta^{\prime 2}+\sin ^{2} \theta\left(\phi^{\prime}+\varkappa\right)^{2}-\sin ^{2} \theta \cos ^{2} \phi . \tag{3}
\end{equation*}
$$

Here and below prime ' denotes the derivative with respect to the dimensionless coordinate $\xi=s / \ell$ with $\ell=\sqrt{\mathcal{A} / K_{\text {eff }}}$ being the characteristic magnetic length, the dimensionless curvature $\varkappa(\xi)=\ell \kappa(\xi)$, and $E_{0}=S \sqrt{A K_{\text {eff }}}$ being the characteristic energy of a domain wall in the rectilinear segment of the wire.

## 3. General results: magnon eigenmodes for a weakly curved wire

Let us start our analysis with a static solution, which corresponds to the minimum of the energy functional (3). The ground magnetization distribution for the planar curved wire is also planar: the magnetization lies in the wire plane (i.e., the osculating or TN-plane), hence the equilibrium state has the form

$$
\begin{equation*}
\Theta=\frac{\pi}{2}, \quad \Phi=\Phi(\xi) . \tag{4a}
\end{equation*}

The corresponding azimuthal magnetization angle $\Phi$ is described by the equation of a nonlinear driven pendulum (see Appendix A for details):

Let us discuss the EVP (8) for $\Omega>1$, i.e., $\varepsilon<0$. In this case we get the scattering problem for the complex-valued function $u(\xi)$ with the asymptotic scattering conditions

$$
u(\xi)= \begin{cases}\mathrm{e}^{i q \xi}+\mathcal{R e} \mathrm{e}^{-i q \xi}, & \text { when } \xi \rightarrow-\infty,  \tag{9}\\ \mathcal{T e}^{i q \xi}, & \text { when } \xi \rightarrow \infty .\end{cases}
$$

Here $\mathcal{R}=R \mathrm{e}^{i \delta_{r}}$ and $\mathcal{T}=T \mathrm{e}^{i \delta_{t}}$ are the complex amplitudes of reflected and transmitted magnons, respectively. The corresponding scattering phases are $\delta_{r}$ and $\delta_{t}$.

Below in this section we analyze the EVP (8) for the infinitesimally weak curvature, $|\varkappa| \ll 1$. In this limiting case the effective potentials (6b) read

$$
\begin{equation*}
V(\xi)=W(\xi)=-\frac{\varkappa^{2}(\xi)}{2}+\mathcal{O}\left(\frac{\left|\varkappa^{\prime}\right|}{|\varkappa|}\right) . \tag{10}
\end{equation*}
$$

When the frequency $\Omega>1$, the solution for the straight wire reads $u(\xi) \propto \mathrm{e}^{i q \xi}$, with $v(\xi)=0$ and $\Omega=1+q^{2}$, where $q=k \ell$ is the dimensionless wave number. Due to the curvature, the two equations for the magnon amplitudes, (8), become coupled. Nevertheless, far from the bend region, the coupling potential $W$ is small. Neglecting all second order terms due to curvature in (8), it gets the form of the usual Schrödinger equation, see (A9) for details. Then the scattering problem of magnons by the bending becomes equivalent to the scattering problem of a quantum particle by the potential $V(\xi)$ and the scattering boundary conditions (9). In particular, in the case of a weak potential, $|V| \ll 1$, the Born approximation is valid,

$$
\begin{equation*}
\tan \delta_{t}=-\frac{1}{2 \sqrt{\varepsilon}} \int_{-\infty}^{\infty} V(\xi) d \xi, \tag{11}
\end{equation*}
$$

which results in the following phase shift

$$
\begin{equation*}
\delta_{t}(q)=\arctan \frac{\Delta}{q}, \quad \Delta=\frac{1}{4} \int_{-\infty}^{\infty} \varkappa^{2}(\xi) d \xi . \tag{12}
\end{equation*}
$$

Note that $\delta_{t} \approx \pi / 2-q / \Delta$ for $q \ll 1$ and $\delta_{t} \approx \Delta / q$ for $q \gg 1$.
Now let us consider the local modes (bound states) inside the gap with the frequency $\Omega \in(0,1)$, i.e., $\varepsilon \in(0,1)$. In this case both functions $u$ and $v$ become localized. One can always choose $u(\xi)$ as a real-valued function. The function $u$ has the asymptotic behavior of the form $u(\xi) \propto \mathrm{e}^{-\sqrt{\varepsilon}|\xi|}$.

Under the same assumptions, the EVP is equivalent to the quantum-mechanical problem about the energy eigenvalue of a quantum particle in a shallow well. It is known that the Hamiltonian $H_{\lambda} \equiv-\partial_{\xi}^{2}+\lambda V(\xi)$ always has a bound state for all small positive $\lambda$ if the potential $V(\xi)$ is negative on average, i.e., $\int_{-\infty}^{\infty} V(\xi) d \xi<0$. The corresponding eigenvalue $\varepsilon$ is determined as follows $[33,34]$

$$
\begin{equation*}
\sqrt{\varepsilon}=\frac{\lambda}{2} \int_{-\infty}^{\infty} V(\xi) d \xi+\mathcal{O}\left(\lambda^{2}\right) . \tag{13}
\end{equation*}
$$

The corresponding frequency of the local mode and the eigenfunction are

$$
\begin{align*}
& \Omega^{\mathrm{loc}} \approx 1-\Delta^{2} \\
& u^{\mathrm{loc}}(\xi) \approx \begin{cases}u_{0}, & \text { inside the well, } \\
u_{0} \exp (-\Delta|\xi|), & \text { outside the well, }\end{cases} \tag{14a}
\end{align*}
$$

where $u_{0}$ is a normalized constant and $\Delta$ is determined by (12). In physical units

$$
\begin{equation*}
\omega^{\mathrm{loc}}=\omega_{0}\left\{1-\frac{1}{16}\left[\int_{-\infty}^{\infty} \varkappa^{2}(\xi) d \xi\right]^{2}\right\} \tag{14b}
\end{equation*}
$$

According to the quantum scattering theory, the presence of bound states influences the scattering data. This influence is given by the Levinson theorem [35]: the total phase shift $\delta_{t}(0)-\delta_{t}(\infty)$ is related to the number of bound states (i.e., local modes) $N^{\text {loc }}$ and half-bound states (i.e., half-local modes) $N^{\text {h.loc }}$ [36]. In the 1D case the total phase shift reads [37]

\frac{\delta_{t}(0)-\delta_{t}(\infty)}{\pi}=\left\{\begin{array}{cl}
N_{\mathrm{e}}^{\mathrm{loc}}+\frac{1}{2} N_{\mathrm{e}}^{\mathrm{h} \cdot \mathrm{loc}}-\frac{1}{2}, & \text { even parity }  \tag{15}\\
N_{o}^{\mathrm{loc}}+\frac{1}{2} N_{o}^{\mathrm{h} . \mathrm{loc}}, & \text { odd parity. }
\end{array}\right.
$$

We will use the Levinson theorem in the form (15) in order to check the number of local modes.

## 4. Magnon eigenmodes for a wire with a box curvature

Let us consider a simple model of the curve, which has a constant curvature $\varkappa_{0}$ in the interval $s \in\left[-\xi_{0}, \xi_{0}\right]$ and vanishes outside (box-function curvature):

$$
\begin{equation*}
\varkappa(s)=\varkappa_{0} h\left(\xi+\xi_{0}\right)-\varkappa_{0} h\left(\xi-\xi_{0}\right), \tag{16}
\end{equation*}
$$

where $h(\xi)$ is the Heaviside step function, $\varkappa_{0}=\ell / R$ is the curvature of the arc bending with $R$ being the curvature radius, and $\xi_{0}=(\pi-\alpha) R /(2 \ell)$ with $\alpha$ being the expansion angle, the angle between the non-bending part of the curve, see Figs. 1(b), (d). If we consider the non-intersecting curve, then $\alpha \in(0, \pi)$.

In the limiting case of weak curvature, $\left|\varkappa_{0}\right| \ll 1$, the ground state has a form of two hooks in the points of curvature step with exponential tails:

$$
\Phi(\xi)= \begin{cases}-\varkappa_{0} \mathrm{e}^{-\xi_{0}} \sinh \xi, & \text { when }|\xi| \leq \xi_{0},  \tag{17}\\ -\operatorname{sgn}(\xi) \varkappa_{0} \mathrm{e}^{-|\xi|} \sinh \xi_{0}, & \text { when }|\xi|>\xi_{0},\end{cases}
$$

see Figs. 2(a), (b). Then the effective potentials (10) are

$$
V(\xi) \approx W(\xi) \approx \begin{cases}-\frac{\varkappa_{0}^{2}}{2}, & \text { when }|\xi|<\xi_{0}  \tag{18}\\ 0, & \text { when }|\xi|>\xi_{0}\end{cases}
$$

see Figs. 2(c)-(f) for comparison with the exact form (6b).

Let us consider the EVP (8) with box potentials (18). For the shallow well $\left(\varkappa_{0} \ll 1\right)$, one can find

$$
\begin{equation*}
\varepsilon \approx \frac{\varkappa_{0}^{4} \xi_{0}^{2}}{4}, \quad \text { when } \varkappa_{0} \ll 1 \text {, } \tag{19}
\end{equation*}
$$

which is in agreement with (14a). In the particular case of the wide well, namely for the limiting case of a halfcircumference arc $(\alpha=0)$, one gets

$$
\begin{equation*}
\varepsilon \approx \frac{\pi^{2} \varkappa_{0}^{2}}{16}, \quad \text { when } \varkappa_{0} \ll 1 \text { and } \xi_{0}=\frac{\pi}{2 \varkappa_{0}} \gg 1 \text {. } \tag{20}
\end{equation*}
$$

Eigenfrequencies of local modes for different geometrical parameters are shown in Fig. 3. While the asymptotics work well only for narrow wells, the exact analytical solution for a box potential (18) shows a good agreement with simulations for $\varkappa_{0} \lesssim 0.4$. The numerical solution for the initial EVP (8) perfectly agrees with the simulations in the whole range of the calculated data.

The scattering problem corresponds to the EVP (8) for $\Omega>1$. We are mainly interested in the forward scattering of the transmitted wave. The scattering phase $\delta_{t}=\arg \mathcal{T}$, calculated using (B11), is plotted in Fig. 1(d).

## 5. Bound states on a sharp bend

Here we consider a limiting case of a sharp bend when $\xi_{0} \rightarrow 0$ with the fixed opening angle $\alpha$, see Figs. 1(b), (c). In this case, taking into account the relation $\varkappa_{0}=(\pi-\alpha) /\left(2 \xi_{0}\right)$

one obtains

$$
\begin{equation*}
\varkappa=\beta \delta(\xi), \tag{21}
\end{equation*}
$$

where $\beta=\pi-\alpha$ and $\delta(\xi)$ is the Dirac delta-function. The conditions of a smoothly curved wire (A2a) are not valid here. Therefore we start with the initial Eq. (4b), which for the sharp bend reads

$$
\begin{equation*}
\Phi^{\prime \prime}-\sin \Phi \cos \Phi=-\beta \delta^{\prime}(\xi) . \tag{22}
\end{equation*}
$$

For the boundary conditions $\Phi( \pm \infty)=0$ Eq. (22) has a solution

$$
\begin{equation*}
\Phi(\xi)=-2 \operatorname{sgn}(\xi) \arctan \mathrm{e}^{-|\xi|+\xi_{c}}, \xi_{c}=\ln \tan \frac{\beta}{4}, \tag{23}
\end{equation*}
$$

for details see Appendix C. Substituting (23) into (6b) one obtains the potentials in the form

$$
\begin{equation*}
V=-\frac{2}{\cosh ^{2}\left(-|\xi|+\xi_{c}\right)}, \quad W=0 \tag{24}
\end{equation*}
$$

Finally, the EVP is presented by two independent homogeneous Eqs. (C4). Let us first consider the localized states with $\Omega<1$. In this case Eqs. (C4) have the bound solution

$$
\begin{gather*}
u=C \mathrm{e}^{-\sqrt{\varepsilon}|\xi|}\left[\sqrt{\varepsilon}+\tanh \left(|\xi|-\xi_{c}\right)\right]  \tag{25a}\\
v=0 \tag{25b}
\end{gather*}
$$

and $\sqrt{\varepsilon}=f(\beta)$, see (C6). The corresponding eigenfrequency $\Omega=1-\varepsilon$ reads

$$
\begin{equation*}
\Omega=\frac{1}{2} \cos \frac{\beta}{2}\left[\cos \frac{\beta}{2}+\sqrt{4-3 \cos ^{2} \frac{\beta}{2}}\right] . \tag{26}
\end{equation*}
$$

For details see Appendix C. The dependence $\Omega(\beta)$ is shown in Fig. 4.

Note a perfect agreement of the analytical (solid line) and numerical (dashed) results. The latter were obtained as a numerical solution of the EVP (8), where the $\delta$-function

on the discrete lattice was modeled as

$$
\delta\left(\xi_{i}\right)= \begin{cases}\frac{1}{\Delta \xi}, & \text { when } \xi_{i}=0  \tag{27}\\ 0, & \text { when } \xi_{i} \neq 0\end{cases}
$$

where $\Delta \xi=10^{-2}$ is the step of the discretization. The equilibrium value of the function $\Phi\left(\xi_{i}\right)$ was found by means of a numerical minimization of the energy (3) with $\theta=\pi / 2$.

For the case $\Omega>1$ one obtains a scattering problem. The solution of Eq. (C4a) can be presented in the form of incident, transmitted and reflected waves, see (C7a). The corresponding coefficients of transmission and reflection read

\begin{equation*}
T^{2}=\frac{(\Omega-1) \Omega^{2}}{\cos ^{2} \frac{\beta}{2} \sin ^{4} \frac{\beta}{2}+(\Omega-1) \Omega^{2}} \tag{28}
\end{equation*}
$$

and $R^{2}=1-T^{2}$, respectively. For details see Appendix C. Note that the full transition takes place for the angles $\beta=0$ (rectilinear wire) and $\beta=\pi$ (completely bent wire), while the minimum transition corresponds to the angle $\beta_{c}=$ $=2 \arccos (1 / \sqrt{3})$.

The total phase shift between the transmitted and incident waves is $\delta_{\text {tot }}(q)=\delta_{t}(q)+2 \arctan (1 / q)$, where $q=\sqrt{\Omega-1}$ is the dimensionless wave-vector and $\delta_{t}(q)$ is determined in (C9a). Since $\delta_{t}(0)-\delta_{t}(\infty)=\pi / 2$, the Levinson theorem (15) results in a single bound state.

## 6. Spin-lattice simulations of the magnon dynamics

Our predictions about the localized mode statics and dynamics are verified by performing 3D spin-lattice simulations using the in-house developed program SLaSi [38]. We model the ferromagnetic nanowire with the local box curvature [see Fig. 1(b)] as a classical chain of magnetic moments $\mathbf{m}_{i}$, with $i=\overline{1, N}$. Neighboring moments interact according to the anisotropic Heisenberg model Hamiltonian as follows:

Here $a$ is a lattice constant and $\left.\mathbf{h}_{i} \equiv \mathbf{h ( r}, t\right)$ is a magnetic field being a function of coordinate and time, measured in units of the coercive field $H_{C}=K_{\text {eff }} / M_{s}$. The dynamics of this system is described by a set of $N$ vector Landau-LifshitzGilbert ordinary differential equations, see Ref. 39 for a general description of the SLaSi simulator and Ref. 23 for the details of the simulations of curved wires.

To study the equilibrium magnetization states we consider a chain of $N=3000$ sites with the exchange length $\ell=15 a$. The box curvature part of the wire is placed in the center of the chain with the arc length being $\xi_{0}=(\pi-\alpha) R /(2 \ell)$, where $\alpha$ is the angle between no-bending parts of the wire, which take the following values $(0, \pi / 6, \pi / 3, \pi / 2)$. The curvature of the central part of the wire is varied in a wide range of parameters $\varkappa_{0} \in(0,1.0)$, with a step $\Delta \varkappa_{0}=0.1$. In order to verify our theoretical prediction, we perform our simulation
starting from the tangential magnetic distribution. We simulate numerically the set of $N$ discrete Landau-LifshitzGilbert equations in the overdamped regime with the Gilbert damping $\eta=0.5$ during the long-time interval $\Delta t \gg\left(\eta \omega_{0}\right)^{-1}$. The final state with the lowest energy is considered to be the equilibrium magnetization state. Simulation data are shown in Figs. 2(a), (b) by filled symbols together with theoretical results (solid lines) for small and high curvature.

Figures 2(c)-(f) show a comparison of the exact potentials (6b) with their analytical approximation. The direct numerical calculation of the eigenmodes of (8) precisely agrees with results of spin-lattice simulations in a wide range of curvatures, see Fig. 3(c) and Fig. 4. Frequencies of local modes $\Omega$ are calculated in the following way. After obtaining the equilibrium magnetic state in the system, a pulse of a homogeneous magnetic field along $\hat{y}$ axis is applied to the system. Due to its inhomogeneity in the local curvilinear frame of reference, this pulse generates a wide spectrum of spin waves as well as local modes, which is situated inside the gap of the spin-wave spectrum.

The numerical verification of the Levinson theorem (15) is a way to check the number of bound states inside the bend. We perform simulations of the spin wave scattering on a spin chain of 14000 magnetic moments with a localized curvature $\varkappa_{0}=0.5$ and $\xi_{0}=\pi$, see Fig. 1(c). A spatially homogeneous, time alternating magnetic field is applied between the 1000th and the 6000th chain sites to generate a spin wave propagating through the bend. To determine the phase shift $\delta_{t}$ due to the bend, we compare the spin wave propagation in two different wires with the same material parameters: one is a curved wire and another one is a straight wire of the same length. Spatial magnetization distribution of a given time moment is analyzed in a detector window [see schematics in Fig. 1(a)]. The detector is placed on the same arc length from the source in both wires. The resulting phase shift is plotted in Fig. 1(d). It is clearly seen that there exists one localized mode in the bend.

## 7. Conclusions

In conclusion, the general analysis of the ground state magnetization and spin wave spectrum is performed in the case of a very small curvature of the wire. The equilibrium magnetization distribution deviates from the tangential wire direction only in the region of the wire bend, the corresponding deviation angle is determined only by the spatial derivative of the curvature, resulting in an effective potential well for spin waves. We predict the existence of a curvature induced truly local mode, localized on a bend, with an eigenfrequency below the ferromagnetic resonance. The interaction of the local mode with spin waves, propagating through the bend, results in a shift of the wave phase according to the Levinson theorem. In the limiting case of a sharp bend ( $\delta$-function curvature) the analytically exact expressions for eigenfrequencies of the bound states,
as well as for transmission and reflection coefficients of the scattering process are found.

## Appendix A: Ground state and spin wave spectrum

The equilibrium magnetization states satisfy the energy minimum:

The limiting case of a smoothly curved wire with a localized curvature corresponds to the following conditions:

In the main approach the asymptotic value (5) is valid under the condition $\left|\varkappa^{\prime \prime \prime}\right| \ll\left|\varkappa^{\prime}\right|$.

In order to analyze magnon modes we linearize the Landau-Lifshitz Eq. (1) on the background of the ground state (4a) by considering the small deviations $\vartheta=\theta-\pi / 2$ and $\varphi=\phi-\Phi$. The energy of magnons in the harmonic approximation reads

Since we are interested in the stationary states solution of the form (7), we get an EVP (8). The boundary conditions essentially depend on the type of the problem. For the scattering problem $(\Omega>1)$ one gets traveling waves together with localized modes with the following asymptotic behavior:

Here $c_{i}, i=\overline{1,4}$ are some real amplitudes.
For further analysis it is convenient to shift the potential $U$ by its asymptotic value, $U=1+V$. Then both potentials $V(\xi)$ and $W(\xi)$ are localized. Suppose that we are working under smooth conditions (A2), then $|V|,|W| \ll 1$. One can conclude from Eq. (8b) that $v \approx-\frac{1}{2} W u$, therefore the function $v$ becomes the slave variable in Eqs. (8). Using the explicit asymptotic form (5) for $\Phi(\xi)=\varkappa^{\prime}(\xi)$, one gets Eq. (10). Now, by neglecting the function $v \propto \varkappa^{2} u$, we get from (8) the usual Schrödinger equation of the following form

Applying the conditions $u(-0)=u(+0)$ and $u^{\prime}(-0)=u^{\prime}(+0)$ one obtains the relations $c_{t}=c T \mathrm{e}^{\mathrm{i} \delta_{t}}, c_{r}=c R \mathrm{e}^{\mathrm{i} \delta_{r}}$. Since $\mathcal{A}_{+}(-\infty)=\mathcal{A}(+\infty)$, the coefficients $T$ and $R$ play the role of transmission and reflection coefficients, respectively:

R=\frac{\cos \frac{\beta}{2} \sin ^{2} \frac{\beta}{2}}{\sqrt{\cos ^{2} \frac{\beta}{2} \sin ^{4} \frac{\beta}{2}+q^{2}\left(1+q^{2}\right)^{2}}} \tag{C8b}
\end{equation*}

The corresponding phase-shifts read

\begin{gather*}
\delta_{t}=\arg \left[q\left(q^{2}-\cos \beta\right)-i \cos \frac{\beta}{2}\left(2 q^{2}+\sin ^{2} \frac{\beta}{2}\right)\right]  \tag{C9a}\\
\delta_{r}=\delta_{t}+\frac{\pi}{2} \tag{C9b}
\end{gather*}

Note that for the case $\Omega>1(\varepsilon<0)$ Eq. (C4b) has only localized bound solutions. In this case $v=0$ for the same reasons as above.
