## AUTHOR GUIDELINES CONCERNING PUBLICATIONS IN "NEWS OF PHARMACY" JOURNAL

## General requirements

"News of Pharmacy" journal publishes authentic articles devoted to theoretical and practical achievements in the field of pharmacy.

Authentic articles (up to 10 pages) devoted to the problems of management and economy of pharmacy, synthesis, analysis, technology, research of the biological activity of physiologically active substances and drugs, experimental and clinical pharmacology are submitted for consideration; they should contain theoretical or experimental research results, which have not been published previously.

Corrected proofs must be returned to the Editorial office within 2 weeks of receipt. When exceeding the term the manuscript will be re-registered as a newly taken one with the corresponding change of the date of its publication. In the author's proof it is permitted only the corrections of errors made during the composition.

Articles should contain the following elements: problem definition in general and its connection with important scientific or practical tasks; analysis of the latest research and publications, in which the solution of the problem initiated and which the author reffered to, separation of the previously unsolved parts of the general problem, which the given article is devoted to; formulation of aims of the article (task setting); presentation of the basic research material with complete substantiation of the research results obtained; conclusions concerning the research performed and prospects for further development in the given direction.

Submission of articles

Articles are submitted to the Editorial office in two copies with the referral of the organization where the work is performed for the Chief Editor's name and the expert evaluation allowing their open publication. The second copy of the article is signed by all authors.

Authors of the articles submitted to the Editorial office for publication in the journal confirm with their personal signatures on the copies of their manuscripts:

- their consent to record-keeping of the authors' data required for the articles processing (full name, academic title, academic degree, position and place of work, address for correspondence, office telephone, E-mail) by the Publisher with the purpose of providing relations in the field of intellectual property rights, including copyright;
- the permission for publication of personal data of the authors (full name, academic title, academic degree, place of work, office telephone, E-mail) in the journal together with the article;
- their consent to making public the complete on-line version of the article (or abstracts) on the sites of the National University of Pharmacy, National library of Ukraine named after V.I.Vernadsky and other portals of academic periodical publications with the obligatory reference and maintenance of moral right.

A floppy disk in MS Word format containing the identical material is added to the manuscript.

The information about authors should be given with the article on a separate sheet of paper, they include: academic title, academic degree; surname, first and second name (in full); place of work and position of the author; address, telephone and fax numbers, E-mail for correspondence.

The electronic version of the article can be submitted additionally (address: press@ukrfa.kharkov.ua).

Requirements for Manuscripts

The text of the article is printed in size 14 in 1.5 spacing on a white basic standard sheet A4 (the width of the text file is 3 cm on the left, 1 cm on the right, 2 cm on the top and at the bottom); it begins with the following data: UDC, the title of the article, the initials and surnames of all authors, the names of organizations where the work is performed, 5-8 key words in Ukrainian, Russian and English.

Authors should pursue the general plan of the composition of the article.

1. Introduction. It contains the problem definition, a brief review of the works published previously in the field under study, the relevance of the research and the purpose of the work are stated.

2. Experimental part (Materials and methods). It contains description of the methods used or developed, equipment and conditions of measurement. In the chemical procedures the amount of reagents in mole and mass units (for catalysts – mass and mole percentage), the volumes of solvents, the amount and yields of the compounds obtained are given. The data of ultimate analysis or mass-spectrum of a high resolution should be submitted for all compounds synthesized for the first time. In empirical gross formulas the elements are arranged according to the Chemical Abstracts system: C, H and then according to Latin alphabet.

3. Results and discussion. They contain the research results obtained by the author. The content of the work should be described clearly and briefly, avoiding the known statements, repetition of results in the text, tables and figures. For chemical compounds, which are described in the article for the first time, or those that are the main target of the research the full name according to the IUPAC nomenclature is given together with the formula.

4. Conclusions.

5. The list of the literature used, which is given in alphabetical order (at first the Cyrillic alphabet, then Roman letters). The list of literature in the article should contain publications for the last 10 years. The earlier publications are allowed only in special cases; 60% of literature sources should be in a foreign language.

Each paper in the list of literature should be reffered to in the text of the manuscript.

Three summaries of the article in Ukrainian, Russian and English as an extended abstract of 200-220 words of a typescript text containing the UDC index, the title of the work, initials and surnames of all authors, the name of the institution(-s) are presented.

These summaries should be informative (do not contain only general phrases), comprehensive, well-defined (the logic of results description in the article should be repeated), brief and clear, with forceful.

The formulas of compounds are submitted in separate files in Corel Draw 13; Chem Win, ISISdraw; diagrams and figures – in Excel or Corel Draw 13; figures in the form of photos can be presented by TIFF 300-600dpi Gray Scale files (256 grayscale). The width of graphics should be 8.4 cm or 17.4 cm in size. It is undesirable to depict structural formulas on figures and tables.

The CI system of units should be used in articles.

Figures and captions are done separately one from another; captions for all figures of the article are presented on a separate sheet. On the backside of each figure its number and the name of the article are given with a graphite pencil and, if necessary, its top and bottom.

Tables should be printed on separate sheets and have numbering and headings. It is necessary to indicate the place of location of figures and tables on the margin of the manuscript. The information given in tables and figures should not be duplicated.

Manuscripts made without the given rules are not registered by the Publisher and they are not returned to the authors.
