

#### RISC-RELEVANT COMPONENT OPTIMIZATION OF NET PREMIUM IN UNDERWRITING RATE

In the article making estimation aspects for risk-relevant types of insurance are researched. The task of risk-relevant component optimization of net premium in underwriting rate is considered. The comparison between the offered algorithm and estimation by the methods of Russian Insurance Supervision Service  $(08.07.1993 \ N_{2} \ 02-03-36)$  is made. This research allows to confirm that the volume of underwriting rate and order of its formation has a significant influence on the provision of enough insurance premium for insurance company reserve formation and effective relationship between an insurance company and an insured person. It was made the conclusion that the decrease in rate based on the mathematical calculation will give significant advantages in the competition for a prospective client. It may be mentioned that the author's method of risk-relevant component optimization of net premium in underwriting rate is more developed than the methods of oversight bodies (Russian Insurance Supervision Service).


