Political and legal basis of integration collaboration of Ukraine and OSCE

The investigation of political foundation and prospects of integration collaboration of Ukraine and OSCE is the main aim of the article. Ukraine's joining the integration processes that have covered practically all countries in the world is an objective and natural phenomenon. The essence and main task of these integration processes are national states survival under the severe conditions of global economical development. Having applied general scientific principles of cognition (historicism, system approach and objectivity) there were analyzed political and legal basis of collaboration of Ukraine and OSCE. Such kind of collaboration was initiated by both parts virtually from the moment of Ukraine's obtaining the status of independent state.
