Regional subdivisions in matters of religions in the structure of organs of executive power of Ukraine and Poland: the comparative analysis of organizational specific and functional setting

The aim of the article is realization of comparative analysis in relation to specific organizational units in the existence of regional religious affairs in Poland and Ukraine. To achieve this goal such methods as analytical, structural, functional and methods of synthesis and generalization have been applied. Analyzing different

and common aspects of regional subdivisions in matters of religions in Ukraine and Poland, we can say that these units exist in Ukraine in twenty–seven of administrative centers, respectively, in Poland in sixteen. Changing of their names and structural subordination both in Ukraine and in Poland is connected to the reorganization of the central authority in matters of religions. The feature of regional subdivisions on Religious Matters in Ukraine is their dual subordination, both to the management of the regional state administration and state authority in matters of religions. There is decentralization of functions of these structural subdivisions in Poland. Within one province, these functions can be distributed from one to four departments.
