ПРАВОВИЙ СТАТУС ЛІКВІДАЦІЙНОЇ КОМІСІЇ В УКРАЇНІ

In this article is conducted the analysis of theoretical and practical issues, related to the creation, functioning, rights and responsibilities of the liquidation committee during procedure of legal entity liquidation, that is essential in the conditions of market economy. The analysis of problem situation showed that execution of basic tasks of this body in the context of providing the mechanism of termination activity needs elimination of problems in this process.

Through generalization of legal base and analysis of practical experience in this field were made practical proposals, which can be used to improve the regulatory framework that governs creation and functioning of liquidating commission to ensure the legal procedures of terminating of the entities.
