MANAGEMENT OF RISKS OF LIFE SAFETY IN MODERN CONDITIONS

Due to the intensive social development of mankind, accompanied by the introduction of new technologies of production, exploitation of natural resources, the growth of information flows and rates of life, new threats to the population arising from natural, man-made and social factors arise and actualize. The overcoming of these threats is a matter of life safety experts.

Organization of life support of the population in emergency situations in accordance with the Code of Civil Protection of Ukraine "citizens of Ukraine have the right to protect their lives and health from the consequences of accidents, catastrophes, major fires, natural disasters and demand from the Government of Ukraine, other bodies of state executive power, administrations of enterprises, institutions and organizations irrespective of the forms of ownership and management of guarantees regarding its implementation. The state as a guarantor of this right creates a system of civil protection, aims to protect the population from the dangerous consequences of accidents and catastrophes of technological, environmental, natural and military character. "The main function of the bodies of state executive power, administrations of enterprises, institutions and organizations, regardless of the forms of ownership and management, in the event of the emergency, is the protection of the population and the organization of its life support.

The right to safe livelihoods in Ukraine, in addition to the Constitution of Ukraine, is guaranteed by a system of nationwide organizational engineering, sanitary and hygienic, anti-epidemic and other measures aimed at preventing emergencies. At the same time, for the territory of the countries of the former USSR, the risk (death from unnatural causes) is close to 10 * 2 * per year, which is 3-5 orders of magnitude higher than the normative level established in the EU. Significant increase in the number and magnitude of natural disasters and man-made disasters in recent decades is connected both with the growth of the population and the development of an increasingly large territory of the planet, and with the unceasing use of ever more powerful (and not always properly controlled) technologies of adapting the world to ever-growing human needs, has led to a significant increase in the attention of governments of national states and international institutions to the problem of reducing the natural and man-made risk.

In order to ensure sustainable development of the society, the system of education in civil security should cover not only the training of highly specialized specialists in fire safety, civil protection, law enforcement, but also all sectors of the population. The mission of education in civil security should be the formation of a person's social responsibility for the viability of himself and his colleagues on the

basis of the formed security thinking.

WAYS OF PERFECTION FUNCTIONING FORCES CIVIL DEFENCE: MANAGEMENT OF MATERIALS BY BACKLOGS

An important element of managerial activity is the preparation and adoption of sound management decisions. In the scientific article, based on the analysis of the tasks defined in the Code of Civil Protection, as well as the actions of the authorities and civil defense forces in emergency situations, a mathematical apparatus is proposed for determining the necessary (sufficient) material reserves to increase the effectiveness of the actions of civil defense forces units in the emergency response.

In the article a mathematical device for calculating material reserves (MR) is required to ensure the operation of equipment and weapons in the performance of emergency rescue and other types of work.

Some indicators of the reliability of weapons are used to assess the impact of material reserves on the effectiveness of the operation of the Civil Defense Force units during the liquidation of the National Assembly and its consequences.
