ARCHITECT THOMAS HARRISON (1744-1829) (BIOGRAPHIC PAGES OF CREATIVE WORK)

An art historian L. N. Timofeyev by virtue of comparative research suggested that the author of the original Vorontsov's Palace in Odessa project is a renowned English architect Thomas Harrison (1744 - 1829), who worked in style of the late classicism, as for City architect Frans Boffo the latter built the Palace after some alterations and on-site adjustment. This hypothesis, is indirectly proved by M. S. Vorontsov himself in his request to Odessa Building Committee in 1822:" ... thus I will soon submit for the Committee's approval the plan of buildings considered by me..."

We can conclude from the above citation, that as far as in 1822 M. S. Vorontsov was already in possession of the Palace's project. According to some evidence architect Thomas Harrison, being on close terms with Semen Romanovitch Vorontsov - father of Michail Semenovitch, had completed number of projects for Southern estates of the Vorontsovs. And it is quite possible that one of those could have been taken as a foundation for the further projection by F. Boffo.
