Different luminosity turns out in different points. On a plane will meet with the homogeneous stream of rays sent to her under one corner. A plane will get homogeneous luminosity on all draught. The problem of determination of parameters of architectural environment, which is needed for optimization of forms of housing building, needs an improvement. The handling of light and shade is the main tool to work with another form of the ancient architect. Today in the architectural planning it is needed: introduction in Ukraine of the European harmonization of national normative base with the norms of the European standards.
