

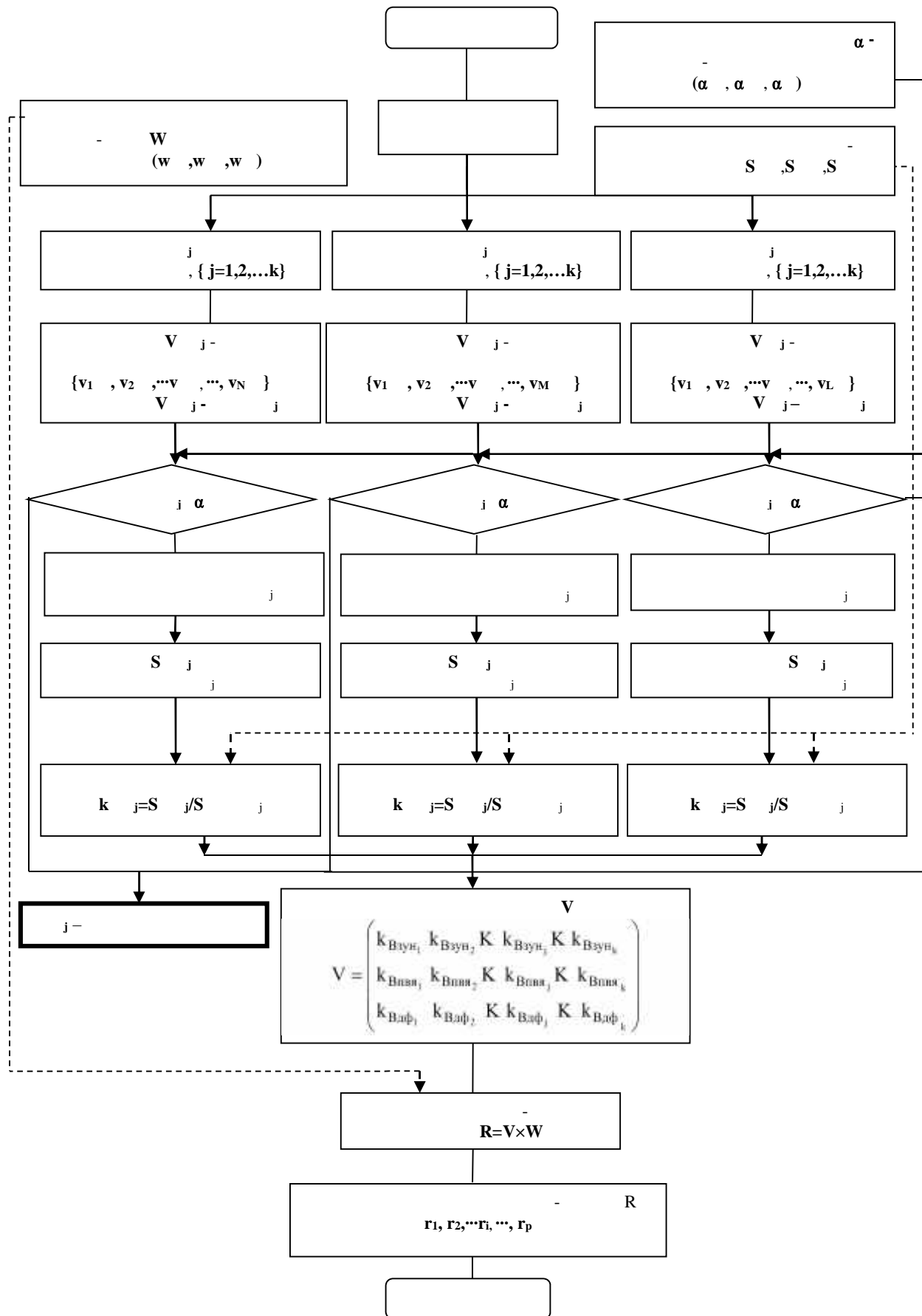

**METHOD OF EVALUATION OF LEVEL OF INDIVIDUAL CAPABILITIES
