The problems of informational-technological support of professional training of teachers in the system of postgraduate education are considered in the article. Creation of educational institutions of the new type in Ukrainian educational network (supporting schools with the net of branches) and their associations (educational districts) needs from managerial staff the mastering of grounds of the matrix and network system of the management of educational institutions, and from postgraduate educational institutions – the new approaches to the formation of managerial professional competences.

The features of organization of educational environment of postgraduate pedagogical educational institution for continuous teaching of managers of network educational organizations were revealed in the study. The model is built on the andragogical principles of managerial staff professional development. It includes four basic levels: educational institution, educational district, urban district (united territorial community), regional center of education development.

At the research there was carried out the generalization of the different classifications of interdisciplinary connections, on which use the professional competence of future ecologists is formed at the study of academic discipline "Monitoring of environment". This research favors the elaboration of the structural-logic scheme of the process of future ecologists' training for mastering the polyfunctional professional competences as a result of integrated study. Four main content blocs of interdisciplinary implementation were separated at the structural-logic analysis:

- fundamental (disciplines of the natural-scientific training course);

evaluative (disciplines that develop mathematical, axiological, qualitological abilities for solving certain ecological problems); — applied (connections that form the ability to evaluate the influence of harmful factors on environment, to determine and elaborate the arrangements as to protection and saving of natural resources);

- system-modeling (connections that provide the ability to: the use of ecosystem approach for the analysis, diagnostics, prognostication of ecological problems).

The professional competences were specified by the content-thematic models of the natural-scientific and professionally oriented cycles of training in integral study of environment monitoring. In general all existing connections may be referred to the system-modeling ones, because they are aimed at the formation of fundamental-professional-practical competences that favors the solution of complicated, complex ecological problems. The knowledge of professional training are deepened, generalized, gain scientific character due to interdisciplinary integration that favors the introduction of changes to the content of learning programs and their renewal

The analysis of the features of introduction of the social-pedagogical accompaniment of foreign students' socialization in educational-cultural environment of a higher educational institution is realized in this article. There is offered to consider the social-pedagogical accompaniment of foreign students' socialization as a type of social-pedagogical activity, directed on their protection, help and support in the process of acculturation by interaction of accompanied person (foreign student) with accompanying person (social pedagogue, tutor, dean's office worker, professor or other person, who realizes the accompaniment), which results are in creation of the optimal conditions for the effective development of their sociality (intercultural and social-professional components). The directions of the social-pedagogical accompaniment realization are explained in the context of necessity of strengthening attention to foreign students' socialization in HEI educational-cultural environment under conditions of higher education internationalization: Activity on training of environment representatives for the effective intercultural interaction with foreign students;

- activity on training of foreign students for self-organization in HEI educational-cultural environment;

During the third millennium the humanity faced the multilevel problems. Their solutions require specialists with new level of thinking. All the attempts to solve these problems on transdisciplinary level do not give the appropriate result, because usually specialists don't go further beyond the boundaries of their subject areas. Since 1970 the transdisc pi inary approach has been developed, within the framework of which the scientific worldview is expanding, and problems are considered at several levels simultaneously without limitation, by the limits of any one scientific discipline. The aim of research is to determine the influence of sectional training in health-improving running on the health level of pupils of the middle school age.

28 pupils of 5–6 classes took part in the research. The duration of pedagogical experiment was 8 months. The activities took place 5 times a week: physical training 3 times, according to the learning program for secondary educational institutions, and pupils visited the section of health-improving walking and running 2 times, during 45 min.

The improvement of pupils' physical health was observed in the process of activities. It was revealed, that under the influence of health-improving running activities there took places the harmonious physical development, the economy of cardio-vascular system of organism increased, pulse at rest decreased. The mood, cheerfulness and mental working capacity increased.

The training in school section is a beginning of active life, good mood, health, study. The section of health-improving walking and running gives a possibility to compensate the motor activity in the structure of school children's motor regime, help to avoid hypodynamia and diseases

In the article the dependence of educational systems of Poland and Ukraine, including the pre-school education, from a political line-up are examined. The author presents basic educational documents, ratified by governments which had an influence on the reorganization of pre-school education: on the changing of types and forms of ownership of pre-school establishments, the change of maintenance of education, as well as the change of approach to the employment of teachers in the pre-school educational institutions. The statistical data has been stored. They showed quantitative changes in Polish and Ukrainian pre-school educational establishments during 2000-2015.
