INFORMATION PARAMETERS OF THE HIGHER EDUCATION QUALITY ASSURANCE SYSTEM 14

The theoretical-methodological and practical principles of the system of providing higher education institutions with the quality of educational activity and the quality of higher education (internal quality assurance system) are presented in the paper. It is shown that implementation of the system of internal quality assurance includes carrying out a number of stages and procedures, among which, inter alia, the monitoring of processes related to educational activities, by determining the information parameters of the components of the quality function; comparison of actual values of information parameters with normative ones; analysis of the results, and on the basis of the analysis - establishment of the need for regulation of processes (managerial, main, provisioning) and implementation of managerial influences (corrective actions). Formulas for calculation of information parameters are proposed and the choice of normative values of these parameters is grounded. It is shown that the deviation of the actual values of information parameters from the normative ones is the basis for forming and making managerial decisions.
